#### ABOUT US

Snehalaya - Centre for Persons in need of Special Care is a Thane based registered voluntary Non-Profit Non-Governmental Organization involved in the training, day care and rehabilitation of *Persons with Intellectual and Developmental Disabilities or Specially-Abled or Differently Abled*.

Registered in January 2006, Snehalaya started activity in June 2007. Snehalaya accommodated up to 25 individuals in the previous year, all above the age of 16 years, under day-care and vocational skill development. In coming year, Snehalaya will expand its services to have a respite care facility.

Snehalaya is a secular trust, with audited accounts till date, and is registered under Maharashtra Public Trust Act 1950, with Charity Commissioner, under Persons With Disability Act 1995 (now RPD Act 2016), and with The National Trust, Government of India, Delhi. Snehalaya is also, a member of Parivaar – National Confederation of Parents Association at the national level consisting of more than 300 members, and a member of Parivaar Sahyadri consisting 48 members at State Level.

Snehalaya provides a safe space for individuals with intellectual and developmental disabilities, after graduating from special schools (i.e., post 18, or some cases 15). We aim to help exploring their potential and abilities, so they are able to channelise and utilise them to its fullest.

#### HIGHLIGHTS OF THE YEAR

Due to the Covid pandemic, the physical premises for Snehalaya were close from Mar 17, 2020 to March 2021.

o In the month of *December 2020*, we had the opportunity to work with Green Spaces, headed by our dear friend, Mrs. Srilata Iyer.

She came out with a proposal to start a Christmas kit with products from Snehalaya and other NGOs connected with us. All the products in the kit were eco friendly and made with degradable material or Upcycled material to keep conservation as the main focus. There



were 4 NGO products in the kit. Products like upcyled plastic bottle lights, the beer bottle lights and the masks, products candle stands made of bamboos, decorative palm.leaf products, Christmas tree made in paper. The Roll on which is a very good Ayurvedic medicine effective against mild cold cough, aches etc acts as a very good protection during these pandemic times. The stars and the greeting cards are made by Snehalaya.

By this kit Snehalaya and Green Spaces tried to support the livelihood and empower the women who were economically hit because of Covid19 by selling their products in Christmas kit and also trying to raise funds for Snehalaya, of around Rs.20,000/-.

 In January – February 2021, Snehalaya led renewal of Niramaya beneficiaries and enrollment for new members through online and calls from home/registered office. 102 renewals were done and 32 new beneficiaries were enrolled. We also helped in clearing several claims. ÷
